

**KIIM-FM, K-HIT, THE VIBE & WILDCATS RADIO 1290'S "BEER FOR A YEAR" CONTEST
OFFICIAL RULES**

A complete copy of these rules can be obtained by contacting radio station KIIM-FM, KHYT-FM, KSZR-FM, KCUB-AM ("Station"), 575 W Roger Road Tucson, AZ 85705, during available business hours Monday through Friday, on the Station website www.kiimfm.com, www.khit1075.com, www.975thevibe.com, www.wildcatsradio1290.com or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **KIIM-FM, K-HIT, The Vibe & Wildcats Radio 1290's "Beer For A Year"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age twenty-one (21) years older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last **60 days** or a prize valued at \$500 or more in the last **180 days**, and whose immediate family members or household members have not won a prize from the Station in the last **60 days** or a prize valued at \$500 or more in the **180 days**. **Void where prohibited by law.** Employees of Station, **Radio LLC** and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The approximate retail value ("ARV") of each prize is Eight Hundred Dollars (**\$800**).

Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
